Program Details

Description: Faith Group and Armanino will discuss the Department of Defense’s Cybersecurity Maturity Model Certification (CMMC) and its implications on the Defense Industrial Base (DIB). The presentation will include an overview CMMC: the evolution of DFARS cybersecurity requirements leading to CMMC; key stakeholders in the CMMC ecosystem, as well as the maturity model itself and associated maturity levels. The presentation will also address the current state of CMMC and the potential for revisions in the upcoming final rule to address criticisms that the current approach is overly burdensome on the DIB. Finally, the presentation will suggest next steps to prepare for future CMMC compliance.

Speakers:

Chris Kadlick is a Senior IT Security Consultant for Faith Group, LLC and a United States Navy veteran. He is responsible for providing cybersecurity consulting and best practices for Faith Group. Chris started his cybersecurity career at Scott Air Force Base in 2008 as a Security Systems Engineer for AVAYA Government Solutions and won numerous meritorious coins from the base commanders. Chris’s experience includes three years as a Senior Engineer for Valdez International where he managed and trained 30 Exchange Engineers and wrote hundreds of PowerShell scripts. He spent five years leading the Information Security department for Emerson Electric where he developed, deployed, and monitored Information Security through technology, best practice, validation, and oversight. He has a Masters in Information Security and Assurance from Western Governors University and is a Certified Information Systems Security Professional (CISSP), Certified Hacking Forensics Investigator (CHFI), Cisco Certified Entry Network Technician (CCENT), and Microsoft Certified Systems Engineer (MCSE).

Robert Hof (Bob) is a Senior Manager in Armanino’s Risk Advisory and Assurance Services practice, where he has responsibility for providing cybersecurity and IT audit services to the firm’s clients. Robert started his career at Brown Smith Wallace (Armanino predecessor firm) in 2007 as an intern and returned to Armanino in 2019. Robert’s experience includes three years in PwC’s Risk Assurance practice auditing controls in support of SOC and financial reporting, two years leading the security architecture of Enterprise Holding’s Office 365 and Azure cloud adoption, and three years leading the cybersecurity team within Charter Communication’s Internal Audit department. He has a BA in Management Information Systems from Lindenwood University and is a Certified Information Systems Auditor (CISA), Certified Information Security Manager (CISM), Certified Data Privacy Solutions Engineer (CDPSE), and Certified Information Systems Security Professional (CISSP).

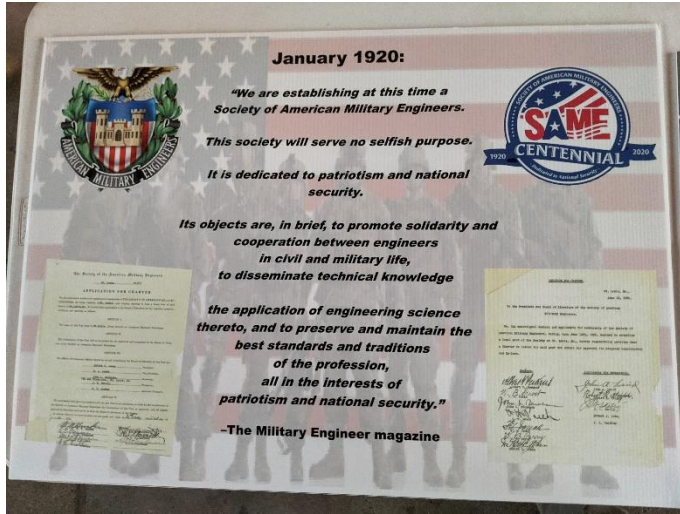
