SAME OMAHA POST – BOARD MEETING Minutes November 7, 2023

President Ryan Watzke called the meeting to order at Noon; quorum declared at 11:57am.

Brec Wilshusen offered the September and October **meeting minutes** for consideration. Tom Svoboda moved—and Kandi Srb seconded—acceptance of both; without objection, the motion passed.

Ryan is targeting earlier December committee sessions for by-law review & updates, org chart & officer updates, and post-shared electronic storage. Also, LDP applications are due December 1st, and these require time to get endorsement letters, etc, for a complete submission.

Brian Schuele emailed his **Treasurer**'s reports earlier this morning; these are attached below. Noting the substantial checking balance, Tom Svoboda moved—and Chris Artz seconded—to transfer \$50K from Checking to the Investment account. Much discussion ensued. **Projection:** Ryan requests an "escrow-like" analysis for next year.

Relationships – Bobbi Lang Lang emailed her report: 761 Individual Members and 113 Organizational Members (this is an increase in individuals but a decrease in organizational which is to be expected. All the numbers will hopefully even out at the first of the year according to National.

Young Member & College Outreach – Stephanie Ling & Bobbi Jo Lang (via email) report the UNL Student Chapter had two great events—a UNL Networking event and an Offutt site event. We are continuing to work through getting the students registered as official SAME members. We did have a new UNO student join us for SBC that Dave Packard facilitated; he had a great experience and made it home safely, and should be a great addition to UNO's student chapter.

Veterans Outreach – Rob Hufford reported (via email) "the 21 Oct 2023 PHWFF event went really well! 45 members showed up at Halleck Park to fish."
