Offutt AFB and 55 CES Profile

- 55 CES Vision: Safely provide uninterrupted facilities, utilities, and emergency services
- Support 55th Wing, 53 tenant units, and 57,000 customers
- \$3.8B of infrastructure on 3,633 acres including 8.2M sf facilities, 3.4M sy pavements, 468 dorm rooms, 1,954 privatized homes, \$16.4M annual service contracts















55 CES Project Execution

- 65 Projects Valued at \$132M in FY24 Funds
 - Decentralized (\$8M), Centralized (\$46M) Customers (\$19M),
 Storm/Natural Disaster (\$9M), Congressional Directed (\$50M)
- Project Development Teams (# authorizations)
 - 55 CEN (30), Flood Recovery Office (5), 55 Requirements & Optimization (R&O) (17)
- Contract Execution Teams
 - 55 Contracting, USACE, and AFCEC (*and uniquely AFSVC in FY24)



FY24 Decentralized Funded Projects; \$8M

- 96% aimed at improving mechanical and electrical system improvements and resiliency
 - Dining Facility HVAC Renovation* (executed via AFSVC)
 - Upgrade Switchgear
 - Replace Condensate Tank
 - Repair Mechanical Ventilation System
 - Repair Chillers
 - Repair Heat Exchangers





FY24 Centralized Funded Projects; \$46M

- Focused on electrical resiliency and mission sustainment
 - Micro-Grid, ERCIP, \$41M Construction
 - Phase 1, \$41M funded in FY24; installs 22MW on-site generation
 - Phase 2, \$70M to \$80M proposed for FY25; installs 16MW PV Array and 6MW/6MWH Battery Storage
 - Electric Vehicle Charging Stations, O&M, \$5M Construction
 - Installs 26 charging locations across base



FY24 Customer Funded; \$19M

- 30% Facility Enhancements
- 25% Transportation/Parking
- 13% Site Enhancements
- 11% Electrical Resiliency
- 9% Monumentation
- 7% Airfield Repair/Maintenance
- 4% HVAC Resiliency





FY24 Storm Funded Projects; \$9M

- 90% comprise Roof Damage and Interior Water Damage
 - 61% Roof Damage (executed via AFCEC's central Roofing IDIQ)
 - 29% Water Damage
 - 8% Fire Suppression/Plumbing Systems
 - 2% Refrigeration Unit Replacements* (executed via AFSVC)



FY24 Congressionally Directed Spending; \$50M

- Base Operations/Mobility Center, MILCON, \$3M Design
- 55 CES Complex, MILCON, \$3M Design
- Rpr Vehicle Search Area, UMMC/MILCON, \$8M Construction
- 55 LRS/Transportation Facility, MILCON, \$3M Design
- Defense POW/MIA Accounting Agency (DPAA) Forensic Laboratory Facility, MILCON, \$5M Design
- B500 Renovation/Consolidation, O&M, \$28M Design

Survivable Airborne Operations Center (SAOC)

Offutt selected as the preferred location and are authorized to begin the NEPA process





Dorm Complex

- Two new dorm facilities are needed
 - Approx \$100M/facility
- Two major renovations
 - Approx \$45M/facility
- One minor renovation
 - Approx \$8M
- DFAC facelift and Food 2.0 upgrades
 - Approx \$7M







Child Development Center

Initiative to bring off-base CDCs on base

Currently have a waitlist for care

Increase in personnel drives additional space requirements

Approximately \$45M







Demolition

- AF directive to eliminate infrastructure to reduce sustainment requirements
- O'Malley Inn, B436; awaiting approx \$3M for design/demo
- Supply/Storage Facility, B404; designed, awaiting approx \$2M for demo
- More in the future







Consolidated Training Complex

- Create a new college-style facility
- Approximately 50,000 sq ft
- Relocating multiple Education, Training, and Military Family Services from on-base to 25th Street Corridor
- Approx \$60M
