





### Acquisitions and Contractual Authority

 Acquisitions and contractual commitments can only be made by Government officials having expressed authority to enter into such agreements on behalf of the United States Government. The ONLY Government officials with such authority are Warranted Contracting Officials. Any discussions of contractual requirements do not constitute contractual direction or authorization of any kind. Future contractual directions, If ANY, shall ONLY come from the cognizant Department of Veterans Affairs Warranted Contracting Officer.



# VISN 20 Capital Asset Program

### **REAL PROPERTY** = land, buildings, structures

- Capital investments associated with the acquisition/disposal of or improvements to VA owned or leased Real Property
- Real Property Agreements
  - <u>VA issues to others</u> for others use of VA owned Real Property via permits, revocable licenses, enhanced use leases, outleases, easements, etc.
  - <u>Others issue to VA</u> for VA use of non-VA owned Real Property via permits, revocable licenses, leases, easements, etc.
- Capital asset and engineering operational lifecycle processes from strategic capital investment planning, execution of approved/funded investments, regulatory compliance (e.g. The Joint Commission, NEPA, NHPA, etc.) and steady state engineering maintenance and operations.
- Activation planning and execution = the furnishing, equipping and initial supplies associated with renovated, new or leased real property.



# • MAJOR Projects >\$30M

This category includes capital projects to construct, alter, extend, or improve a facility or service where the cost is expected to exceed \$30 million (or where funds were previously provided by Congress under the Major Construction appropriation). Projects for medical facilities must receive authorization through legislation and must be approved and funded through the Congressional budget process. Design and planning funds for medical projects do not require authorization,

Major Projects may address gaps, enhance outpatient and inpatient care, and update special program space, such as spinal cord injury, blind rehabilitation, seriously mentally ill, and long-term care. Major projects also include seismic retrofit projects to correct seismic deficiencies.

In 2025, the major construction budget includes funding for two prior year projects at West Los Angeles, California and Dallas, Texas, as well as one cemetery project in Denver, Colorado, and line items.

Design and construction contracts on VA Major Projects with a Total Project Cost >\$100M are executed by the USACE. Thank you USACE for partnering with VA and including VA Major projects in your presentations!



## • MINOR Projects <\$30M

A capital project that constructs, alters, extends, or improves any facility with costs equal to or less than \$30 million. Minor construction funds can also be used for planning and assessments of needs, which may lead to spending on capital investments and other costs. Minor Projects construct new building square feet.

# • Non-Recurring Maintenance (NRM)

NRM projects are intended to improve existing space without constructing ne space. There are three categories of NRM projects:

**NRM - SUSTAINMENT:** These projects involve converting functional space to a different program function within existing buildings or spaces, without adding any new space, at a cost equal to or less than \$30 million.

**NRM - INFRASTRUCTURE MODERNIZATION:** These projects involve making improvements to, and providing for new, building systems without changing the function of the existing space. There are no dollar limits on project costs, but any work over and above that done on the underlying building system cannot exceed 25% of the total project cost. Note: New Infrastructure Building square feet such as for a Boiler Plant is allowed.

**CLI - CLINICAL SPECIFIC INITIATIVES:** These projects are emergent needs that cannot be planned due to dynamic health care environments. Examples of projects include women's health, mental health, high-tech/high-cost medical equipment site prep & installation; donated building site preparation (e.g., Fisher House) and reducing the footprint reduction (demolition or conversion of underutilized space to clinical functions).

### President's Budget Request - Fiscal Year 2025:

U.S. DEPARTMENT OF VETERANS AFFAIRS FY 2025 BUDGET SUBMISSION



The U.S. Department of Veterans Affairs (VA) is requesting a total of \$369.3 billion in fiscal year (FY) 2025, a 9.8 percent increase above FY 2024 estimated levels. The FY 2025 budget provides robust funding for the Secretary's top priorities. This includes 134 billion in discretionary funding and resources for <u>health care</u>, <u>benefits</u> and <u>national cemeteries</u>. Additionally, there is \$235.3 billion in mandatory funding, an increase of \$41.8 billion or 21.6 percent, above 2024 for benefit programs, inclusive of Compensation and Pensions, Readjustment Benefits, Housing and Insurance, and continued funding for the Toxic Exposures

Fund.

VA 2025 Major Construction, Minor Construction and NRM Budget Request




Figure E-1: 2025 VA Major, Minor and NRM Budget Request (Dollars in thousands)

# VISN20

### FY25 Capital Budget Request

For the Veterans Health Administration (VHA) the majority of capital funding is allocated to Non-Recurring Maintenance (NRM) Projects

Total Budget Request is \$4.8 billion

The 2025 VA capital budget request of \$4.8 billion includes investments in a number of asset categories across several organizations and accounts. Table E-1 (below) provides a breakout of capital budget request by Administration and Staff Offices (SO). This includes the \$307 million in discretionary resources anticipated to augment Minor Construction from the Recurring Expenses Transformational Fund (RETF).
