Young Member & College Outreach: Stephanie Ling reported the MCC student chapter tried to elect new officers in June. Discussion ensued if it were constitutional IAW our by-laws to appoint vice casting ballots.

Industry Day: Kandi Srb emailed three items for the Board from the last Industry Day meeting (with much discussion following):

- Next year will be the 85th Anniversary of the Omaha Post. As you may recall, we had planned an event for the 80th Anniversary during Industry Day in 2000, but Covid cancelled everything. So it is in the works to do a celebration of the 85th during next year's Industry Day. This is just at the beginning stages, but potential locations, timing, sponsorships, etc. are all being considered.
- Related to that a suggestion was made that we should design and produce a special coin to commemorate and give away at Industry Day. The committee requested input from the Board on this idea.
- The overwhelming feedback on the keynote speaker was outstanding, so the committee's intention is to pay for a speaker again next year (in a similar price range of this year's speaker).

Programs: Jake Batenhorst remarked that he has confirmed our speaker for next week, and are "good for the rest of the year". We have 35 reservations for July.

Leadership & Mentoring: Tom Svoboda reports, and Bill Glismann supported, adding a recurring consideration for a the SMP coordinator line item that increases pay each year. Bill further reported the steering committee meeting is still tbd.
