# Sound Transit: Who We Are

- The Central Puget Sound Regional Transit Authority began in 1993 as a joint effort by the Snohomish, King, and Pierce county governments in western Washington state
- Encompassing more than 1,000 square miles, the Sound Transit District is bigger than the state of Rhode Island and is home to more than 40% of Washington's population.
- Builds, maintains, and operates (with partners) Light Rail, Commuter Rail, Express Bus, and Bus Rapid Transit modes
- Focused on Sustainability, Equity, and Transit-Oriented Development







- Established ST Express bus service

- Sounder expansion to South Tacoma, Lakewood



### **ST3** – current phase

- Light rail to Ballard, West Seattle, Everett, Tacoma, Kirkland, Issaquah
- 3 bus rapid transit lines
- 2 new Sounder stations, more capacity, parking and access improvements
